AGREEMENT FOR USE OF SCHOOL BUS FOR FIRE / RESCUE TRAINING

By entering into this agreement, a Fire/Rescue Department can obtain a school bus for extradition training for 120 days at no charge as long as the terms of the agreement are satisfied.

Whereas the organization named below has **120** days to haul the bus to a local salvage company and return funds to North Carolina Department of Public Instruction (NC DPI).

_____ (NAME OF ORGANIZATION) agrees to transport the school bus designated below to a local scrap metal dealer and return all proceeds obtained from sell of the bus for scrap metal to NC DPI. Current market value for scrap metal must be obtained from Salvage Company.

It will be the responsibility of the organization named above and the Local Education Agency (LEA) furnishing the bus to see that funds are sent to NC DPI in the form of a **certified check** made out to "NC DPI" along with weight ticket and receipt from Salvage Company.
