## AGREEMENT FOR USE OF SCHOOL BUS FOR FIRE / RESCUE TRAINING

By entering into this agreement, a Fire/Rescue Department can obtain a school bus for extrication training for 120 days at no charge as long as the terms of the agreement are satisfied.

Whereas the organization named below has **120** days to haul the bus to a local salvage company and return funds to North Carolina Department of Public Instruction (NC DPI).
